

Proceedings of Town Meeting April 7th 1873.

Report of Committee to Name Schools

^{Butter}
No. 1. ^{Butter} Frobridge School - in honor of parson Frobridge who for half a century served the town as its minister and resided on the plot of ground which comprises a portion of the present school grounds.

No. 2. Moors School - in honor of the name of a long family by that name who resided in that section of the town and whose descendants still continue so to do.

No. 3. Dana School - after Judge Samuel Dana.

No. 4. Farbell School - after the Farbells who for generations have made that name familiar in that vicinity.

^{Hobart}
No. 5. Green School - after the old familiar name known in that district.

No. 6. Chicopee School.

^{Frobridge}
No. 7. Willard School - in honor of the name of parson Willard who served as one of the early ministers of the town and afterwards became president of Harvard

^{University}
No. 8. ^{Willard} Butler School in memory of Caleb Butler who served the town in various capacities with credit to himself and honor to the town.

No. 9. Prescott School - after Col. Prescott of revolutionary memory who fell in the Battle of Bunker's Hill. He was born in Groton.

No. 10. Chaplin School - after Rev. Daniel Chaplin D.D. who for many years honorably served the town as its minister.

No. 11. Wentthrop School in memory of the name of the man who petitioned the "General Court" to have the tract of land formerly comprising the territory of Groton set off as a town. Mr. Wentthrop coming from the town of Groton in England - this Township took name of Groton.
