

Proceedings of Town Meeting Novemb^r 2^d 1874 -

Art. 6th Voted - to appropriate the sum of eight hundred dollars (\$800) to finish and complete the Hall in the High School building and the expense thereof not to exceed that amount.

Art. 7th Voted - that the road be discontinued as a public Highway.

Art. 8th Voted - that the sum of Four hundred dollars (\$400) be appropriated to pay the expenses of the reception of the Old Sixth Regiment on the 19th of April next at their reunion in said Town.

Voted - that a Committee of Five persons be chosen to carry out the vote of the Town and

Chas. H. Waters were chosen said Committee.

Also Voted that the Selectmen be requested to memorialize the Legislature to legalize the vote of four hundred dollars appropriated by the Town above.

Art. 9th Voted - that the Town appropriate the sum of one hundred dollars (\$100) to decorate the graves of the Soldiers.

Art. 10th The following motion was accepted and adopted, viz: -

That the names of the several public Schools of Groton, adopted April 7th 1873 be and hereby are changed, so as to read as follows.

No. 1. The Butler School No. 9 The Willard School

" 2 " Moore " " 10 " Prescott "

" 3 " Dana " " 13 " Chaplin "

" 6 " Hobart " " 14 " Winthrop "

" 7 " Chicopee " and Tarbell " as the name of the

" 8 " Froimbridge " School at the new School House at West Groton.

And that the Selectmen be instructed to cause the names to be placed on the several School Houses, according to the above designation.

Art. 11th Voted - that the Selectmen be instructed to pay for services in putting out fires referred to in this article, as the Fire Wards shall audit.

Art. 12th Voted - that Charles H. Waters
Sam^l W. Rowe &
Geo. S. Gates be joined to the Selectmen, to make any improvements and repairs in and around the Town House they may see fit.

Art. 13th The report of the ^{Com^{rs}} chosen in May 1872 to make improvements upon the old burial ground was read, accepted and ordered to be placed on file in the archives of the Town.

Voted that the Selectmen be ordered to draw their warrants for the amount paid out by the Committee over and above the amount of cash in their hands. also

Voted - that a vote of thanks be presented to Mr. Hemenway and a committee be appointed to get up a suitable testimonial to be presented to him for his liberality. and

S. W. Rowe, Geo. S. Gates & Henry A. Bancroft were chosen said Committee.

Voted - that a Committee of one person consisting of S. W. Rowe be appointed, and that a Committee shall be annually appointed to take care of the old burial ground and the sum of fifty dollars (\$50) be appropriated for that purpose, subject to the order of said Committee.

Voted - that the sum of three hundred dollars (\$300) be appropriated to pay Mr. Rowe for his services in improving the old burial ground.

The Meeting was adjourned to on the first Monday in April next at 1 o'clock P.M.
